ProNatural Hydrolyzed Fish is pure fish protein made from clean, undecomposed, whole ocean white fish and fish cuttings. The fish is digested using a cold enzyme hydrolysis process, which breaks down otherwise insoluble fish protein into short chains of amino acids that are soluble in water.

ProNatural Hydrolyzed Fish offers both superb nutritional qualities and the physical convenience of a dry, stable product. As a powder, ProNatural Hydrolyzed Fish is easier to store and handle, more uniform and consistent over time and does not require expensive drums or buckets.

ProNatural Hydrolyzed Fish is used in water sprays as a foliar feed for both perennial tree and berry crops and annual vegetable crops. Applications made early in the season, when soil nutrient availability is low, efficiently provide the required metabolites for protein synthesis during a period of rapid cell division. The potential for cell proliferation is almost never realized and substantial economic benefit can be captured with larger and stronger fruiting structures such as buds, fruit spurs and fruit by supplemental feeding.

The same rationale applies to annual crops except that they are continually in the state of rapid protein synthesis. Annual vegetable crops benefit from regular foliar applications at three-week intervals using 2 pounds per 100 gallons of spray throughout the season.

COMPATIBILITY: Always jar test new combinations for compatibility prior to field mixing.

Do not store in diluted form. Keep sealed in air and moisture tight container. Place opened sacks in sealed plastic bags preventing moisture contamination and caking.

## DIRECTIONS

ORCHARDS AND VINEYARDS
Spray 3-4 lbs. **ProNatural Hydrolyzed Fish** mixed in 20-400 gallons of water per acre (4 lbs. per 100 gals. spray to cover is suggested). Begin 3-4 spray sequence at half leaf emergence and repeat at 7 to 10 day intervals. Farlier applications are deemed more cost effective than Earlier applications are deemed more cost effective than later sprays. May be tank mixed with most orchard and vineyard spray materials.

ROW CROPS
Spray 2-3 lbs. **ProNatural Hydrolyzed Fish** mixed in 20400 gallons of water per acre (2 lbs. per 100 gal. spray to cover is suggested) on emerging new growth and at other plant growth stages when an immediate nutritional boost may be beneficial to growth, production and quality.

## DIRECTIONS (continued)

GARDENS
Mix 2 tablespoons **ProNatural Hydrolyzed Fish** per gallon of water and spray to cover emerging new growth and at weekly intervals or during periods of stress. May be mixed with soluble seaweed in a ratio of one part seaweed to 5 parts ProNatural Hydrolyzed Fish.

GROUND APPLICATION **ProNatural Hydrolyzed Fish** may be applied dry or preferably in solution at 20 lbs. per 100 gals. as desired. Solution can be shanked in at time of seeding field crops. ProNatural Hydrolyzed Fish will not clog emitters and used as a "side dressing" even with systems using micro-perforated drip irrigation tape with sheet mulching and
