4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Clean up spills immediately observing the precautions in Section 8 of this MSDS. Control spill at the source and prevent material from entering soil, sewers, waterways or low areas. Recover materials for reuse or disposal by pumping any free liquid into appropriate closed containers, do not flush to drain.

7. HANDLING AND STORAGE
