SECTION 4: FIRST AID MEASURES IF IN EYES: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Environmental Hazards Statement from FIFRA Regulated Pesticide Label:

Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply where runoff water may flow during periods of intense rainfall or to water-saturated soils, as off-target movement and injury may occur. This product is classified as having high potential for reaching surface water via runoff for weeks after application. A level, well-maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential loading of Metsulfuron methyl from runoff water and sediment. Runoff of this product will be greatly reduced by avoiding applications when rainfall or irrigation is expected to occur within 48 hours.
