• Use ASSURE® II Herbicide at 12 fl oz/A application rate when tank mixing with Engenia® Herbicide (EPA registration number 7969-472), Tavium® Plus Vaporgrip Technology (EPA registration number 100-1623) or XtendiMax® With Vaporgrip Technology (EPA registration number 264-1210)

ADJUVANTS

When tank mixing ASSURE® II with Engenia, Tavium or XtendiMax, always use crop oil concentrate at 1 - 1.5% v/v (1-1.5 gallon/100 gallons water). Use the maximum adjuvant rate in arid conditions.
