For annual grass and select perennial grass control in Enlist Soybeans:

- Use ASSURE® II at 12 fl oz/A application rate when tank mixing with Enlist Duo.
- Use ASSURE® II at 12 fl oz/A application rate when tank mixing with Enlist One. Full control requires
 the addition of a glyphosate containing product utilized at a minimum rate of 0.56 lb ae/A, for
 example:
 - o 16 fl oz of 4.5 lb ae glyphosate/gallon product
 - o 24 fl oz of 3 lb ae glyphosate/gallon product

ADJUVANTS

When tank mixing ASSURE® II with Enlist One or Enlist Duo, always use crop oil concentrate at 1-1.5% v/v (1-1.5 gallon/100 gallons water). Use the maximum adjuvant rate in arid conditions.

APPLICATION INFORMATION

To maximize grass control:

- apply to actively growing, non-stressed weeds
- use nozzle tips and spray pressure that deliver the smallest droplet size allowed by the tank mix partner
