#### **DIRECTIONS FOR USE**

This label and the federal label for this product must be in the possession of the user at the time of pesticide application.

Follow all applicable directions, restrictions and precautions on the SLN label and the main EPA-registered label. It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

#### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. Apply Assure® II at up to 12 fl oz/A for grass weed control in hemp grown for fiber. Apply Assure II to small, actively growing grasses. Refer to Section 3 label for application instructions to specific grass species. Application made to grasses larger than the sizes listed in the label rate charts or to grasses under stress may result in unsatisfactory control. In the event of a subsequent flush of grass, or regrowth of previously treated grass occurs, a second application of ASSURE® II may be applied.

Applications of ASSURE® II must include either a petroleum crop oil concentrate or a nonionic surfactant.

- Apply petroleum-based crop oil concentrate at 1 2% v/v or NIS at 0.25 % v/v.
- An ammonium nitrogen fertilizer may be added to the spray mixture, in addition to crop oil concentrate or nonionic surfactant, but is not required to optimize performance of this product. Use 2 quarts/acre of a high-quality urea ammonium nitrate (UAN), such as 28%N or 32% N, or 2 lb/acre of a spray-grade ammonium sulfate (AMS).

#### Special Adjuvant Types

- Combination adjuvant products may be used at doses that provide the required amount of NIS, COC, MSO and/or ammonium nitrogen fertilizer. Consult product literature or local representative for use rates and restrictions.
- In addition to the adjuvants specified above, other adjuvant types may be used if they provide the same functionality and have been evaluated and approved by AMVAC product Management.

#### **RESTRICTIONS/PRECAUTIONS**

- 1) Do not feed crop residues to livestock or allow animals to graze treated areas.
- 2) All hemp screenings shall be disposed of in such a way that they cannot be distributed or used for food or feed.
- 3) No portion of the hemp plant may be used or distributed for food or feed purposes.
- 4) Hemp may not be distributed for human consumption or animal feed in any form.
- 5) The maximum use rate of ASSURE® II is 24 fl oz/A (0.165 lb ai/A) per crop season.
- 6) Do not make more than 2 applications per acre per season.
- 7) Application intervals must be greater than 7 days apart to allow regrowth to occur.
- 8) Aerial applications are not allowed.
