The addition of 32 or 28% UAN (Urea-ammonium nitrate) at 1% v/v to Persist and Volare adjuvants is required when used with *Regiment* Herbicide. UAN is NOT a substitute for an approved adjuvant, but rather should be used in combination with one of the approved adjuvants.
