DIRECTIONS FOR USE

Apply Xpedient Plus V at the rate of 3.2 to 6.4 fl. oz./A (0.05 to 0.10 lb. a.i./A) per acre in-furrow with the seed or as a 5 to 7 inch band over the open furrow (T-band). May tank mix with other pesticides and fertilizers.

RESTRICTIONS

- Do not apply more than 0.2 lb active ingredient per acre per season as an at-plant application.
- Do not apply to soil where there is 30% cover of crop residue remaining.
- Field corn – Do not apply more than 0.3 lb active ingredient per acre per season including pre-plant incorporated (PPI), at-plant, pre-emergence (PRE) plus foliar applications of other bifenthrin products (such as Discipline 2EC).
- Sweet corn – Do not apply more than 0.2 lb active ingredient per acre per season including pre-plant incorporated (PPI), at-plant, pre-emergence (PRE) plus foliar applications of other bifenthrin products (such as Discipline 2EC).
